Alternatively, a scanned copy of the form may be uploaded using the "Upload Copyright Form" link available in the online submission system. ***The manuscript number must be on all forms and permissions.***

To upload the form:

1. Print all the pages of the Authors' Statement and Copyright Release form
2. Complete the form and have all authors sign the form
3. Scan the completed copyright form and any other applicable documents and save as a PDF file

6. Locate your manuscript; select Copyright Form Needed, select File Management, and select Upload Copyright Form.

Rights of authors: effective upon acceptance for publication, ASN hereby licenses the following nonexclusive rights back to authors:

- (a) Patent and trademark rights to any process or procedure described in the article
- (b) The right to photocopy or make single electronic copies of the article for their own personal use, including for their own classroom use, or for the personal use of colleagues, provided the copies are not offered for sale and are not distributed in a systematic way outside of their employing institution (e.g. via an email list or public file server). Posting of the article on a secure network (not accessible to the public) within the author's institution is permitted.
- (c) The right, subsequent to publication, to use the article or any part thereof free of charge in a printed compilation of works of their own, such as collected writings, theses or lecture notes

Since the ASN owns copyright to all manuscripts published in the *JN* per the Agreement signed on submission of the manuscript, we grant the PI permission to deposit this accepted manuscript in PubMed Central according to the NIH request, with the stipulation that the PI accepts any liability that may arise through release of the manuscript in its present form.. To avoid this potential liability, the ASN suggests that the PI delay submission of this manuscript to PubMed Central until the ASN publication office has completed all required copyediting within the next several months. At that point, the corresponding author will be provided a finished PDF version that will represent the material to be published in the *JN*. Provision of the final PDF version to PubMed Central will avoid all ambiguity that could otherwise result from the presence of one incomplete and the other complete copy of the manuscript.

If the PI decides to submit the unedited version of the manuscript, a further stipulation to the release of the manuscript to the NIH is that it must contain the following statement at the top of the title page: "This is an un-copyedited author manuscript that has been accepted for publication in the *JN*, copyright American Society for Nutrition (ASN). This manuscript may not be duplicated or reproduced, other than for personal use or within the rule of 'Fair Use of Copyrighted Materials' (section 107, Title 17, US Code) without permission of the copyright owner, the ASN. The final copyedited article, which is the version of record, can be found at <http://jn.nutrition.org/>. The ASN disclaims any responsibility or liability for errors or omissions in this version of the manuscript or in any version derived from it by the National Institutes of Health or other parties."

Regardless of whether the un-copyedited version or the copyedited, final version of the manuscript is submitted to the NIH, the PI must abide by the *JN* policy of making articles free online on our website as well as in the NIH repository 12 months after publication. This will satisfy both the *JN* and NIH policies.

Free Access publication option: Authors of accepted original research manuscripts can choose to pay a free access fee to allow their articles to become freely accessible on the journal website immediately upon publication. The free access fee is \$3000 per article and is charged in addition to other author charges (page charges, color reproduction charges, author alteration charges and charges for reprint orders). For authors who elect not to pay the free access fee, articles will remain under access control for the first 12 months after publication. Upon acceptance of an article, authors interested in the free access publication option will be instructed to download the Free Access Choice Form (see *JN* Instructions for Authors, <http://jn.nutrition.org/>) to provide article and billing information. For authors who elect to pay the free access fee, the article will be made freely accessible immediately upon publication. The free access fee, along with the remainder of the author fees (page charges, color charges, cost of reprints), will be billed after publication.
